Eligibility/Evaluation Criteria

- 1) The firms /Company /consultants shall have specific experience of satisfactory completion of similar works (consulting services for survey and preparation of database, GIS based/digitized mapping, planning and preparation of BOQ/estimate and provide training for capacity building of client's personnel.)
- 2) The above experience shall be supported by client's certificate in their letterhead indicating their address, telephone & fax number and details of project, (i.e. name of the project, name of the employers, and description of the work, duration and contract amount). Certificates as evidence must be written in English.
- 3) The consultant shall have requisite number of appropriate key professionals like minimum Graduate Computer/Electrical/Mechanical Engineers and GIS experts etc experienced in the relevant fields (e.g. Survey, GIS based / digitized mapping and distribution network planning etc.) to carry out the proposed consulting services and shall furnish the list of key professionals and their CV.
- 4) The applicant must have average minimum turnover of Rs. 2 Crore and positive Net worth.
