#### **Job Responsibilities:**

- a. Responsible for accurate and timely presentation and reporting of financial information.
- b. Preparation & interpretation of budgets & MIS including variance analysis as per the guidelines laid down by the company and operators.
- c. Compliance with financial regulations and standards wherever applicable.
- d. Establish manage & control the finance & accounts activities and ensuring overall financial discipline in the property.
- e. Formulating strong policies, procedures & internal control.
- f. Manage tax, regulatory & compliance function.
- g. Ensuring timely statutory payments and accurate filing of all returns applicable under relevant acts including GST.
- h. Ensuring smooth and timely audit like internal, statutory, CAG, cost, Concurrent etc.
- i. Conduct monthly Finance Review Meetings to monitor on a timely basis achievement of action plans, identify and highlight deviations, document corrective action and report performance of the same.
- j. To ensure Balance Sheet preparation under IND-AS and GAAP.
- k. Flagging risks to the finances – operational, market etc. and developing strategies to counter / mitigate the same.
- l. Providing information to Owners and Operators to assist in forecasting and budgeting.
- m. Supervising other support functions like purchase, stores, IT, Administration and Operations.
- n. Scan the environment and work towards keeping the organization ready in advance to face the new challenges in the area of financial, accounting, taxation or disclosure requirements being brought by ICAI, Govt. or regulatory bodies for protecting stake- holders interest.

- p. Framing guidelines for award of contracts for activities such as floatation of tenders for various services in procurement.

**Nature of appointment:**

Candidate will be appointed on contractual basis on cost to company basis for a period of 2 years and further extendable based on the performance and requirement of Company. Appointment of any candidate on contract basis will not confer any right of absorption in the regular employment of the company at any point of time. As and when required the appointee may be transferred anywhere at another unit of IIDL.

**Compensation:** CTC will be determined based on the experience, qualifications etc. of the successful/selected candidate with a ceiling of Rs. 1,10,000 /- per month.

**Experience & Qualification:**

Qualified Chartered Accountant with 5 years of relevant work experience.

**Selection Procedure:**

Selection will be made through interview only. A preliminary screening of the applications will be carried out to short-list eligible candidates to be called for the interview. Merely fulfilling the minimum requirements laid down for the post would not automatically entitle any candidate for interview. The place and date of interview will be advised to the short-listed candidates in due course. Candidates are required to bring all original certificates (class 10<sup>th</sup> onwards) with self-attested photocopies on the date of interview.

**Age:**

The maximum age is up to 40 years. All Computations of age shall be done considering 31.01.2021 as the cut-off date. Age Relaxation for SC /ST /OBC (NCL) /EWS/ PWD candidates shall be as per Govt. guidelines.

**General Instructions:**

1. Candidates are advised to read all the instructions carefully before applying and ensure to fulfil stipulated eligibility criteria as on the date of eligibility.
