Prices are to be quoted in Indian Rupees only.

Applicable GST shall be paid by the successful Bidder

The vehicle will be disposed off on "As it is where is basis".

The bidder should deposit EMD of Rs. 5000/- (Rs. Five Thousand only) as DD from a Scheduled Bank before the due date for submission of Quote in favour of IFCI INFRASTRUCTURE DEVELOPMENT LIMITED, New Delhi.

The original EMD document should reach to The SAVP, IIDL Suites, IIDL Suites Plot No. 4A, District Centre, Mayur Vihar, New Delhi before the auction start date. IIDL will not be liable for delay in submission of EMD. Scan copy of the DD should be uploaded in GeM Portal. The bid without EMD (in Original) will be liable for rejection. EMD of the unsuccessful bidder will be returned without interest after finalization of the contract with the successful bidder. EMD of the successful bidder will be released only after realization of sale proceeds and transfer of ownership of vehicle. EMD will not be adjusted in the sale proceeds of the vehicle.
